

My agency, the Ocean Township Police Department, has agreed to become a partner in "Project Medicine drop," led by the New Jersey Division of Consumer Affairs ("Division").

As you know, Project Medicine Drop gives consumers the opportunity to dispose of their unused prescription medications, safely and securely, in secured drop boxes maintained by local law enforcement agencies. This initiative is inspired by the success of the U.S. Drug Enforcement Administration's successful Operation Take Back initiative, and is an important component of New Jersey's effort to halt the diversion and abuse of prescription drugs.

As a Project Medicine Drop partner, my agency will maintain a prescription drug drop box, provided by the Division, at our 50 Railroad Ave. in Waretown, NJ 08758. Our policies and procedures related to Project Medicine Drop will conform to all applicable laws and ordinances, and to the Division's requirements for security and public availability.

I am writing to request a waiver from the U.S. Drug Enforcement Administration, authorizing my agency to receive medications from members of the public into our Project Medicine Drop box, and to store those medications in a secure area prior to their final disposal and destruction.

On behalf of the Drug Enforcement Administration (DEA) New Jersey Division, I would like to thank you in advance for your interest and participation in the State of New Jersey Project Medicine Drop. Your efforts and those of others in law enforcement help create a better environment for our citizens.

Your request has been granted and this letter authorizes you to collect unwanted controlled substances from members of the public for a period of one year from the date of this authorization. The legal requirements for this action are promulgated in Title 21 CRR 1307.21, which provides a procedure for the DEA Special Agent in Charge to grant approval to law enforcement agencies to operate "take back" programs.

As advised you will maintain a secure container under the control of your Department that will allow the public to routinely drop off unwanted, unused, and expired medications.
