## PARTIAL AND CONDITIONAL RECOGNITION OF THE VENTNOR – MARGATE BICYCLE & PEDESTRIAN PLAN

WHEREAS, the Planning Board for the City of Margate (the "Board") has been asked to adopt a Resolution recognizing the Ventnor – Margate Bicycle & Pedestrian Plan dated October 2016 prepared in conjunction with the NJDOT Office of Bicycle and Pedestrian Programs and Urban Engineers, Inc. (the "Plan") as part of the City of Margate's Master Plan; and

WHEREAS, the Board has reviewed the Plan in its entirety and held public discussion on the Plan on June 29, 2017, July 27, 2017 and August 31, 2017, at regularly scheduled meetings at Margate Historic City Hall, 1 S. Washington Avenue, Margate, N.J.; and

WHEREAS, based upon its review of the Plan and the public discussions held, the Board has particular concern for the aspects of the Plan that provide for reducing Atlantic Avenue to two lanes and eliminating the blinking lights along Atlantic Avenue during the off season, and does not recognize those portions of the Plan; and

WHEREAS, the Board also recognizes that the Plan consists of a series of recommendations only and that there is need for further engineering studies and analysis before any Plan can be implemented; and

WHEREAS, subject to and conditioned upon the above limitations, the Board desires to recognize the remaining portions of the Plan.

NOW, THEREFORE, A Motion having been made and seconded, the Board recognizes the Plan as part of the City of Margate's Master Plan, subject to the express limitations and conditions set forth above.
